1.1 EXPLANATIONS

This operating guide book covers the important rules concerning the hauling, installation and operation of gearbox and belt variators. It should always be kept close to gearbox and belt variators where operators could easily reach.

It is only possible to maintain high performance operation without breakdowns by fully complying with the instructions in this operating guide in order to avoid any incorrect operation and provide errorless usage. Therefore, it is obligatory for this operating guide to be completely read and comprehended and demonstrated by each operators and responsible people.



The alterations and additions in this operating guide may only be made by our company, otherwise our company will not be held responsible for the outcomes.

Our company must be contacted with about the problems and applications concerning the issues that are not stated in this operating guide, and written information should be asked about solutions. Be sure that you have chosen the most appropriate gearbox and belt variators for your needs in order to prevent possible risks that might occur.



The gearbox and belt variators that you have purchased have been designed to operate solely and they should never be coupled with other machines.



The gearbox and belt variators that you have purchased have been manufactured according to the provisions numbered 98/37/AT (98/37/EEC) and in this scope, our company is only responsible in condition that the rules in this operating guide are abided by.



The machines, that are to be coupled with the gearbox and belt variators that you have purchased, must fulfil the basic requirements of the provisions numbered 98/37/ AT (98/37/EEC).



2. SECURITY NOTES

Gearbox and belt variators have been manufactured with superior technology and served for usage. For this reason it is forbidden for the user to make any changes on the product. Our company does not undergo the responsibility of such alterations and the risks and faults arising from these changes.



√ The product is only used and operated under the conditions stated in the catalogue and operating guide.



- √ The user must ensure that every person, who are responsible for operating, maintenance, installation and protection of the product, must read and understand the operating guide and that they are cautious for these rules including every points given below:
 - To prevent possible dangers to user's life and organs, and to the third parties.
 - To maintain the safety of products.
 - To prevent inadequate performance and environment pollution that may arise from incorrect installation, usage and maintenance
 - To provide the safety conditions of work and workers during the operation of the product.



√ The product shall be installed, operated, repaired and maintained by only authorized and educated personnel who has been trained about the requirements of the product..



 $\sqrt{}$ The entire work shall be carried out carefully and with safety.





√ The operating guide that is given together with the gearbox-variators should be protected with labels and warnings placed on the product from materials such as paint, dust, moisture etc. and should be renewed when necessary.



√ All work to be carried out on the product (installation, hauling, mounting, maintenance etc.) should only be conducted when the product is at stop position. All safety precautions should be taken in order to prevent the accidental operation of the product. Signs and warnings that would prevent the product to operate, should be placed on the visible parts of the mechanism, which is coupled with the product, and on the start button in order to indicate that these processes continue on the product.



√ Related rules concerning industrial safety and pollution control should be taken into consideration during usage, installation, operation, maintenance and protection.



√ Rotating parts such as coupling, gearwheel or chain gear, belt pulley, trigger belt and V belt should be protected with the help of required precautions in order to prevent possible contacts. (Please apply basic requirements of the provision numbered 98/37/ AT (98/37/EEC) regarding safety precautions).



√ The gearing operation should be stopped immediately if any difference such as the operation exaltation or noise of the gearing is spotted at the gearing mechanism during the operation. The manufacturer or the authorized service should be contacted.





√ During the installation of the geared mechanism at the tools and systems are obliged to include the requirements, notes and instructions stated in this instructions, which produce tools and systems, in their own instructions.



 $\sqrt{}$ The oils used are harmful to health and environment. The contact of this oil with skin and eyes should be avoided.

Old and dirty oil, drained from the product during the oil renewal, should be put into an appropriate container and destroyed without harming the environment. The extremely dirty and greasy cleaning elements should also be kept in appropriate containers and destroyed without harming the environment.



√ In the cases where the product is used with food processing machines or in food
processing environments, the relevant hygiene legislation should be abided by
and the food and the surface of the product should not be contacted. In such
conditions it is preferred for the oil used in the product to be suitable for the food
when necessary.



3. HAULING AND STORAGE

3.1. HAULING



Small gearboxes do not have a hauling handles. These products should be carried by hand with the help of at least two people.

There are hauling rings on gearbox and belt variators in large scale or lifting points on the trunk. (See Page 7). During the haulage of the product, a polyester sling, which is suitable for the weight of the product and hauling handles, a hook and a lifting lug, should be chosen and it should be lifted with an appropriate crane that would lift its weight.

During transportation the product should be fixed upon the transportation vehicle and this way its movement and overturn will be prevented.



During the hauling and lifting, the required security precautions should be taken in order to protect the operators, who carry out this process, from any injury; and it is necessary not to be present under a crane or a product during lifting.

3.2 STORAGE



In cases where gearboxes and variators have to be stored for a long period of time, it is necessary to keep them in a non-humid area where water entrance is avoided, fixed temperature is maintained, and where there is no dust and vibration and also well ventilated. Protective oils that prevent the pivot ends from oxidation should be changed periodically.





Never change the covering over the gearbox and variator. The mechanical (scratches), chemical (acid, alkaline melting) or thermal (spark, solder light, heat) damages that may possibly form on the covering may lead to rusting and outer protection deficiency.



















4. MOUNTING AND DISMOUNTING

4.1 MOUNTING



The gearboxes and variators should only be assembled and operated in assembling positions as indicated in this operating guide. Written permission of the producer should be taken for mounting positions excluding this.

The required measures should be taken in case that the connection points located on the system which is coupled with the product are set free and thus giving harm to the environment and operators by falling is prevented.



Regarding the mounting locations of the variators, and keeping in mind that the variator rotation adjustments are made during the operation, ergonomical and safe areas should be chosen. The basic requirements of the legislation number 98/37/ AT concerning this subject should be applied.




The variators and gearboxes should be operated together with the devices they are coupled with after they are assembled and the volume power level should be measured by a testing device that complies with IEC 651 .The volume power depends on the speed, power rate and power proportions. After the measurement, appropriate precautions that comply with related legal legislations about the effects of noise on humans should be taken.






- I. Before beginning the process of the assembling and/or disassembling of your gearbox and belt variator, you should read the operating guide thoroughly.
- II. Check whether the the ventilation stopper of the gearbox or belt variator you will mount is suitable to the assembling position or not. In case there is any probem, please, contact the manufacturer company. (Please check our catalogue for the correct position of the ventilation stopper.)
- III. If the mechanism you will mount is to work at outdoor environments, make sure that the mounting material you use such as bolts and nuts to fix your gearbox and/or belt variator is made of stainless steel material. Protect your motor and variators against dust, water, moisture and other outdoor conditions.
- IV. Receive affirmation from the manufacturer company that the gearbox and/or belt variator that you will mount will have the correct oil pressure level for its mounting positions.
- V. Never use a hammer during the mounting and dismounting of the connection elements used in the gearbox and belt variators pivots such as coupling, belt pulley, chain gear etc., use a pivot end pulling device for this purpose






VI. The chassis on which you will mount your gearbox and/or belt variator should be straight, clean and rigid.


VII.If a coupling is going to be used,



please assure that there is enough space between the two couplings.



between the output shafts of the gearbox and/or belt variator and the activated machine then make sure that the shafts are on the same axis.



please assure that there is same axis between the two couplings.

When choosing couplings, elastic ones should be preferred, rigid connections are not recommended. The chain gear, belt pulley connections should be made linear and tightly.



5. OPERATION

- I. Fulfilling the requirement as listed in the operating guide, you can demonstrate the operation conditions of your gearbox and/or belt variator and start operation of the product.
- II. For motor-driven type products check if grounding has been applied.
- III. For motor-driven type products be sure that the electrical connections are done correctly and firmly according to the electrical diagram on the klemens box.
- IV. Gearboxes and belt variators may rotate in both ways except for the locked types. For this reason the rotation direction should be checked by putting it on/off and before connecting it to the machine it will drive.
- V. The temperature of the working environment should be between + 5 ° C / +60 ° C. If it will be operated in an environment temperature excluding these intervals, the manufacturer company must be contacted and consulted with.
- VI. Obtain an information document on cooling interval period of your products from the relevant manufacturer and take action according to the listed intervals.



6. CONTROL AND MAINTENANCE

Comply with the maintenance instructions for your gearboxes and belt variators longevity and expected work efficiency.

GEARBOXES:

	Check the oil levels and quantity of your motors. Chose the type and quantity of oil from the İ.MAK catalogue.
	Check if the ventilation stopper is active or not. If the air evacuation hole does not work, the accumulated air in the motor trunk causes pressure and gas leakage from the mats. Thus the oil reduces and causes environmental is pollution and hinders the efficient operation of the motor.
	Check wether the motor connection bolts have loosened or not. Take measures by firming loosened bolts. Be careful for the harmful shaking of the disposition of the axis during motor installation.
	Change the oil after 500 hours of initial operation and periodically every 6000 hours of operating the motor.
	You must contact and consult with our company for special matters and operation conditions.
BELT VA	RIATORS:
	It is necessary to apply oil from the greaser at the relevant parts of the belt variators periodically.
	The adjustment of the rotation interval fixing bolt of the belt variator should not be changed. In case these intervals are changed and the max/min rotation limit values are exceeded, it may cause uninvited damage on the
	belt. It is beneficial to change and operate the rotation of the belt variator regulation system for a few minutes once in a while (at weekends) for the continuous and proper operation of the machine.
	Relevant precautions should be taken to protect from the dusty environments effects as much as possible.

The rotation interval of the belt variator must be done during the operation of the variator.










WARRANTY CONDITIONS

- 1. All gearboxes and variators' parts except the engine are warranted for 2(two) year.
- 2. Conditions in the warranty and user's guide of manufacturer are valid for the Warranty of the Engine.
- 3. This warranty is valid if there is no direct or indirect intervention to the product by the end user and if it is used accordingly to the user's guide.
- 4. This warranty does not cover the defects arising from misuse and wrong choices.
- 5. The time taken for maintenance, repair and replacement made under the warranty shall be added to warranty period. This time starts with the delivery of the product to the service station.
- 6. Warranty period is valid beginning the invoice date, commissioning date is void.
- 7. No interference such as mounting, demounting, or maintenance shall be made to the warranted product on the machine or facility it works.
- 8. Our company does not warrant the parts of other companies which are mounted on our standard product; related company is responsible for the warranty of these products.
- 9. Warranty conditions cover the parts produced by İ-mak Gearbox&Variator Co.; do not cover the customer parts coming with the standard product and damages caused while mounting and demounting these parts.
- 10. This warranty does not cover the damages that may be occurred during transportation.
- 11. Consumers have to inform the manufacturer about their questions on maintenance and repair.
- 12. İ-mak Gearbox&Variator Co. is not responsible for the material and moral losses in case of the failure of the product.
- 13. Our company will supply a free of charge repair in its factory for the product failures under the conditions and period of warranty. Cost of shipment is borne by the user.
- 14. Only the replaced parts of the products, on which revisions are made, are warranted; warrant period for the spare parts is 6(six) months.




